

Promotional Offers Terms and Conditions

CryptoGT promotional offers allows all the MT5 traders to receive different type of Bonuses and Cash Back rebates in their live trading account/s.

A. No Deposit Bonus

1. The No Deposit Bonus is available only for new clients and it is applicable to all crypto deposits and valid through a limited time period (hereinafter the “No Deposit Bonus Period”) which is specified under the “Promotions” tab from time to time in the Company’s website. CryptoGT reserves the right to extend the period at its own discretion. All times are GMT+3.
2. The No Deposit Bonus Promotion (hereinafter the “Promotion”), is offered at the discretion of CryptoGT to the amount specified under the “Promotions” tab in the Company’s website to new approved Clients of CryptoGT. Clients that register and are approved after this Promotion expires will not be eligible for the bonus (hereinafter the “No Deposit Bonus”).
3. The No Deposit Bonus will be credited to the Client’s Account as a Credit instantly and shall be available for trading purposes only.
4. The No Deposit Bonus will be automatically cancelled in case a Client withdraws money during or after the promotion period.
5. The No Deposit Bonus will apply per client, therefore, if the client holds multiple accounts in the same or different Cryptocurrency, he/her is eligible to receive the No Deposit Bonus only once in the first account that was registered during the promotional period. If the client registered an account before the promotional period, he/her shall not receive the No Deposit Bonus for any account that was registered during the promotional period.

B. First Time Deposit Bonus

1. The First Time Deposit Bonus is available only for clients that make their first deposit and it is applicable to all crypto deposits and valid through a limited time period (hereinafter the “No Deposit Bonus Period”) which is specified under the “Promotions” tab from time to time in the Company’s website. CryptoGT reserves the right to extend the period at its own discretion. All times are GMT+3.
2. The First Time Deposit Bonus Promotion (hereinafter the “Promotion”), is offered at the discretion of CryptoGT to the first deposit amount and to a maximum specified under the “Promotions” tab in the Company’s website from time to time to new approved Clients of CryptoGT. Clients that register and are approved after this Promotion expires will not be eligible for the bonus (hereinafter the “First Time Deposit Bonus”).
3. The First Time Deposit Bonus will be credited to the Client’s Account as a Credit instantly and shall be available for trading purposes only.

4. The First Time Deposit Bonus will be automatically cancelled in case a Client withdraws money during or after the promotion period.
5. The First Time Deposit Bonus will apply per client, therefore, if the client holds multiple accounts in the same or different Cryptocurrency, he/her is eligible to receive the First Time Deposit Bonus only on the first deposit in any of the accounts during the promotional period. If the client registered an account/s before the promotional period, and never made a deposit, he/her shall be eligible to receive the First Time Deposit Bonus during the promotional period.

C. Second Time Deposit Bonus

1. The Second Time Deposit Bonus is available only for clients that make their second deposit and it is applicable to all crypto deposits and valid through a limited time period (hereinafter the “Second Time Deposit Bonus Period”) which is specified under the “Promotions” tab from time to time in the Company’s website. CryptoGT reserves the right to extend the period at its own discretion. All times are GMT+3.
2. The Second Time Deposit Bonus Promotion (hereinafter the “Promotion”), is offered at the discretion of CryptoGT to the second deposit amount and to a maximum specified under the “Promotions” tab in the Company’s website from time to time to new approved Clients of CryptoGT. Clients that register and are approved after this Promotion expires will not be eligible for the bonus (hereinafter the “No Deposit Bonus”).
3. The Second Time Deposit Bonus will be credited to the Client’s Account as a Credit instantly and shall be available for trading purposes only.
4. The Second Time Deposit Bonus will be automatically cancelled in case a Client withdraws money during or after the promotion period.
5. The Second Time Deposit Bonus will apply per client, therefore, if the client holds multiple accounts in the same or different Cryptocurrency, he/her is eligible to receive the Second Time Deposit Bonus only on the second deposit in any of the accounts during the promotional period. If the client registered an account/s before the promotional period, and never made a second deposit, he/her shall be eligible to receive the Second Time Deposit Bonus during the promotional period.

D. Any Time Deposit Bonus

1. The Any Time Deposit Bonus (hereinafter the “Promotion”), is available for clients that make any deposit and it is applicable to all crypto deposits and valid through a limited time period (hereinafter the “Any Time Deposit Bonus Period”) which is specified under the “Promotions” tab from time to time in the Company’s website. CryptoGT reserves the right to extend the period at its own discretion. All times are GMT+3.
2. The Any Time Deposit Bonus Promotion (hereinafter the “Promotion”), is offered at the discretion of CryptoGT to any deposit amount and to a maximum specified under the “Promotions” tab in the Company’s website from time to time to approved Clients of CryptoGT. Clients that register and are approved after this Promotion expires will not be eligible for the bonus (hereinafter the “Any Time Deposit Bonus”).

3. The Any Time Deposit Bonus will be credited to the Client's Account as a Credit instantly and shall be available for trading purposes only.
4. The maximum bonus will apply per client if he/her holds two accounts ("the maximum account limit") in the same Cryptocurrency. If the client holds multiple accounts in different Cryptocurrencies, then he/her is eligible to receive the maximum bonus in both accounts.

E. General Bonus Terms and Conditions

1. Transfers between CryptoGT trading accounts are not considered as deposits for the purposes of any Bonus Promotion.
2. The Bonus is non-transferable between CryptoGT trading accounts and cannot be withdrawn.
3. If multiple accounts under the same email or different email address but share the same I.P address, will be considered as the same Client.
4. If the Company suspects that clients registered accounts using different email addresses for the purpose of taking advantage of any promotion, will be considered as an abuse and violation of terms and conditions.
5. CryptoGT reserves the right at its own discretion without any prior notice to cancel any Bonus and/or disable the client's account/s if abuse of the promotion and its terms is suspected.
6. The Company reserves the right to refuse offering any type of Bonus at its sole discretion without the need to provide justification. The Company will not be liable for any stop outs or any other consequences that result out of a Bonus cancellation and/or removal.
7. The Bonus shall be removed if the terms and conditions of this Promotion are not met.
8. By participating in any bonus promotion, the client acknowledges that has read and agreed to be bound by these terms and conditions of the promotion together with CryptoGT's standard Customer Agreement and Operative Agreements as well as to all other Business terms and conditions.
9. In the event of any dispute in relation to any bonus Promotion, such dispute shall be resolved by CryptoGT acting in good faith and as, in its sole and absolute discretion, deems fit and proper. CryptoGT's decision shall be final and binding.
10. CryptoGT reserves the right, at its sole discretion and as it deems fit, to alter, amend, suspend, cancel or terminate any bonus Promotion, or any aspect of the Promotion at any time and upon any reasonable cause. Under no circumstances shall CryptoGT be liable, for any consequences of any alteration, amendment, suspension, cancelation or termination of this Promotion.
11. The Company reserves the right, at its absolute discretion, to deny, withhold or withdraw from a Client any Bonus and/or to terminate Client's participation or access to the Promotion if a Client acts in bad faith or in a manner that CryptoGT deems not to be in the spirit of the Promotion.
12. Notwithstanding the translated language of these T&C's, the English wording shall be the binding version in the event of any discrepancy between the various languages.

F. Cash Back Rebate

1. The Cash Back Rebate (hereinafter the “Promotion”), is applicable to all financial products as specified in the Promotions tab and valid through a limited time period (hereinafter the “Cash Back Period”) which will be specified under the “Promotions” tab from time to time in the Company’s website. CryptoGT reserves the right to extend the period at its own discretion. All times are GMT+3.
2. CryptoGT has the right to withdraw without prior notice the Cash Back earned if:
 - a) A breach of these Terms and Conditions occurs;
 - b) Upon expiration of the promotion, the trading terms are not satisfied;
 - c) The Company has reasonable grounds to believe a misuse of the Cash Back Promotion;
 - d) Client attempts to withdraw any part of the Cash Back before satisfying the Trading Terms;
 - e) CryptoGT has reasonable suspicion that the Client uses an expert advisor or other means to exploit prices and takes advantage of the promotion;
 - f) Client frequently opens and closes a position in less than 60 seconds taking advantage of the promotion.
3. CryptoGT will not be liable for any margin call or losses that you may suffer, including but not limited to losses due to Stop-out Level, if the Cash Back is withdrawn for any reason pursuant to the Terms and Conditions set out herein.
4. CryptoGT reserves the right, as it in its sole discretion deems fit, to alter, amend, suspend, cancel or terminate the Promotion, or any aspect of the Promotion, at any time and without any prior notice. Under no circumstances shall CryptoGT be liable for any consequences of any alteration, amendment, suspension, cancellation or termination of the Promotion.
5. Any indication or suspicion of fraud, manipulation, Cash Back arbitrage, or other forms of deceitful or fraudulent activity in a client’s account or multiple accounts with CryptoGT or otherwise related or connected to the Cash Back Promotion will nullify any and all transactions carried and/or profits or losses garnered therein. CryptoGT reserves the right, at its sole discretion, to disqualify any individual that misuses or attempts to misuse the Promotion or breaches the present Terms and Conditions and/or any of CryptoGT’s Business Terms and to cancel all orders and annul all profits of such client. In these circumstances, CryptoGT shall not be liable for any consequences of the Cash Back cancellation.
6. In the event of any dispute or misinterpretation of the above applicable Terms and Conditions, such dispute or misinterpretation shall be resolved as CryptoGT acting in good faith and as it shall, in its sole and absolute discretion, deem fit and proper. CryptoGT’s decision shall be final and binding.
7. By participating in the promotion, the client acknowledges that has read and agreed to be bound by these terms and conditions of the Promotion together with CryptoGT’s standard Customer Agreement and Operative Agreements as well as to all other Business terms and conditions.
